The Grundy County Board of Health (LBOH) met on Tuesday, December 20<sup>th</sup>, 2022, at 7:00am in the Conference Room at the Grundy County Annex Building in Grundy Center, IA. Per the Iowa Public Information Board: Electronic Meetings for a Governmental Body, minutes must include a statement explaining why an in-person meeting was impossible or impractical. Special meeting of the LBOH for FY24 Budget Review was called to order by Hach.

## FY24 Budget Review/Administrative Position Wage Discussion/Action Approval of Both:

VanDeest expense and revenue forms for FY24, talking about line items and what they mean. Administrative position wage setting was discussed by board with information sharing from that gathered by department and chair. Motion to increase current salary position of administrator by 12% (\$6553.44), which will increase line item to \$110,764.00, by Eilers; seconded by Rains; approved. Motion to approve/submit budget to BOS of \$213,082.00 for FY24 by Eilers; seconded by Petersen; approved. Hach will attend next Board of Supervisors (BOS) meeting with GCPH.

**Discussion of Medical Provider:** Bombei states we can go without a medical provider for a short while until one is found. The BOS is the entity that appoints the position and is requested that they help find someone to fill that role. Currently, medical providers are at capacity and are difficult to find. LBOH will still inquire about possibilities.
