Called to Order, 10:31am

The Grundy County Board of Health (LBOH) met on Friday, February 7<sup>th</sup>, 2025, at 10:30am in the Conference Room at the Grundy County Annex Building in Grundy Center, IA for a special meet-and-greet with LBOH and Board of Supervisors (BOS) personnel, as well as Environmental Health. 
