RESOLUTION #51-2023/2024

Resolution to Approve Addition of County Property to the Conrad Urban Renewal Area of the City of Conrad, Iowa

WHEREAS, the City of Conrad, Iowa (the "City") has begun the process of adding territory to its Conrad Urban Renewal Area (the "Urban Renewal Area"), pursuant to Chapter 403 of the Code of Iowa; and

WHEREAS, the property which is proposed to be added to the Urban Renewal Area is located outside the city limits, such property being described on Exhibit A hereto (the "Property"); and

WHEREAS, in accordance with Section 403.17(4) of the Code of Iowa, a city may exercise urban renewal powers with respect to property which is located outside but within two miles of the boundary of that city, but only if the city obtains the consent of the county within which such property is located; and

WHEREAS, the City Council of the City has requested that the Board of Supervisors of Grundy County, Iowa ("Grundy County") adopt this resolution giving its consent that the City may exercise urban renewal powers with respect to the portions of the Property lying within two miles of the incorporated city limits; and

NOW, THEREFORE, it is hereby resolved by the Board of Supervisors of Grundy County, Iowa, as follows:

Section 1. The Grundy County Board of Supervisors hereby gives its consent that the City of Conrad may exercise urban renewal powers pursuant to Chapter 403 of the Code of Iowa with respect to the Property situated in Grundy County and outside the incorporated boundaries of the City.

Section 3. This Resolution shall be deemed to meet the statutory requirements of paragraph 4 of Section 403.17 of the Code of Iowa and shall be effective immediately following its approval and execution.
