A RESOLUTION OF THE BOARD OF SUPERVISORS OF GRUNDY COUNTY, IOWA, AUTHORIZING THE CHAIRPERSON TO SIGN THE 1ST ADDENDUM TO THE MANAGEMENT AND SERVICES AGREEMENT FOR HOME CARE AIDE AND PUBLIC HEALTH NURSING PROGRAMS.

WHEREAS, the Grundy County Board of Health, Grundy County Board of Supervisors, and Allen Memorial Hospital entered into a Grundy County Management and Services Agreement for Home Care Aide and Public Health Nursing Programs on January 1, 2002, and


WHEREAS, on January 1, 2011, Allen Memorial Hospital assigned the Agreement to Unity Point at Home (previously InTrust) pursuant to 1.2 Assignment, and

WHEREAS, the parties desire to add this addendum to waive the one-year prior written notice required for termination of the Agreement by section 2.2, and

WHEREAS, Unity Point at Home desires to terminate providing services under the FY2017-2018 Grundy County Substance Abuse Prevention Agreement and FY18 Home Care Aide Services Agreement.

NOW THEREFORE BE IT RESOLVED THAT the Board of Supervisors of Grundy County, Iowa, approves the 1st Addendum to the Management and Services Agreement for Home Care Aide and Public Health Nursing Programs with Unity Point at Home and hereby authorizes the chairperson to sign said 1st Addendum.

**1st ADDENDUM TO THE
MANAGEMENT AND SERVICES AGREEMENT
FOR
HOME CARE AIDE AND PUBLIC HEALTH NURSING PROGRAMS**

THIS 1ST ADDENDUM to the Agreement is entered into by and between Grundy County Board of Health ("Board of Health"), the Grundy Board of Supervisors ("Supervisors"), and UnityPoint at Home ("UPAH").

RECITALS

WHEREAS, the Board of Health, Supervisors, and Allen Memorial Hospital entered into a Grundy County Management and Services Agreement for Home Care Aide and Public Health Nursing Programs ("Agreement") on January 1, 2003, and

WHEREAS, on January 1, 2011, Allen Memorial Hospital assigned the Agreement to UPAH (previously InTrust) pursuant to 1.2 Assignment, and

WHEREAS, the parties desire to add this addendum to waive the one year prior written notice required for termination of the Agreement by section 2.2.

WHEREAS, UPAH desires to terminate providing services under the FY 2017-2018 Grundy County Substance Abuse Prevention Agreement (Agreement B) and FY 18 Home Care Aide Services Agreement (Agreement C).

NOW THEREFORE, in consideration of the mutual promises and other consideration set forth herein, the parties agree as follows:

The Board of Health, Supervisors, and UPAH mutually agree that the written Notice of Intent to Terminate Agreements B and C dated November 17, 2017 will be deemed proper Notice and any irregularities in the service of said Notice are hereby waived.

The Board of Health, Supervisors, and UPAH mutually agree that Agreement, Agreement B, and Agreement C will terminate on June 30, 2018.
