WHEREAS, it is desired to make appropriations for each of the different officers and departments for the fiscal year beginning July 1, 2023, in accordance with Section 331 434, Subsection 6 of the Code of Iowa NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Grundy County, Iowa as follows:

Section 2: The amounts lemized by fund and by department or office and the schedule below.

Section 3: Subject to the provisions of other county procedures, regulations, and applicable state law, the appropriations authorized under Section 1 shall constitute authorization for the department or officer listed to make expenditures or incur obligations from the itemized fund, effective July 1, 2023.

Section 3: In accordance with Section 33 1,437 of the Code of lowa, no department or officer shall ascertain that the available resources of a fund for that year will be less than said fund's total appropriation, shall establish separate accounts for the appropriations authorized in Section 1, each of which shall indicate the amount of the appropriation, the amount charged thereto, and the unencumbered balance. The Auditor shall report the status of such accounts to the applicable departments and officers searched water. <u>Section 5:</u> The Adultor shall establish separate accounts for the appropriations authorized in Section 1, each of whic monthly during the 2023-2024 budget year.

<u>Section 6:</u> All appropriations authorized pursuant to this resolution lapse at the close of business on June 30, 2024.
